Program Committee Sets Schedule for "A Summer of Coolidge"

Bolstered by 14 new committee members, the Program Committee has been working hard planning the beginning of the 2010 season called "A Summer of Coolidge."

As the Calvin Coolidge Memorial Foundation is set to celebrate the 50th Anniversary of the Foundation in 2010, it is fitting that we take advantage of this important anniversary to bring the legacy of President Calvin Coolidge to the nation and to highlight what the Foundation has accomplished in the last 50 years.

Thanks to the support and leadership of *The Rutland Herald*, "An Evening With Coolidge" is being planned at The Paramount Theater in Rutland for June 10, 2010. A keynote speaker will address the crowd with an important look back at the Coolidge presidency and what contributions were made during his six years in The White House. Cocktails and hors d'oeuvres will be served. *Information will be announced soon.*

Who can forget Fourth of July? The only U.S. President to be born on Independence Day, hundreds will gather at The Notch at 12 Noon on Sunday, July 4th to walk with the Vermont National Guard Color Guard a few hundred yards to the burial place of Calvin Coolidge and numerous Coolidge family members. Traditionally, the White House sends a beautiful wreath, which will be laid on the tombstone of President Coolidge. Following at The Notch, a guest speaker will address the crowd

and share stories and history of our 30th U.S. President. A solemn and respectful event, all are welcome to commemorate President Coolidge's birthday, his birthplace, and his legacy.

The National Advisory Board of the Coolidge Foundation will be invited to a dinner gathering the evening of Friday, August 6th in Woodstock, Vermont. This will be an occasion for the NAB to get re-acquainted, meet the current Board of Directors and Foundation staff, review the new Strategic Plan, and hear all the details of the new Coolidge Education Center and Museum at Plymouth Notch. *Information will be announced soon.*

Named the biggest event in the State of Vermont in 2010 by *The Vermont Standard*, the official opening of the Calvin Coolidge Education Center and Museum at Plymouth Notch is scheduled for Saturday, August 7th. This impressive construction project will be complete and it will be an exciting day to visit the Homestead that was the birthplace of Calvin Coolidge. Also known as Old Home Day, starting at 9 a.m., the Foundation's Annual Meeting will be conducted in the Union Church with keynote speakers and attendance by numerous dignitaries on hand to see the new Center. Governor Jim Douglas will be on hand for the official ribbon cutting, followed by guided tours that will take visitors through the new Center, where vaults protect the Coolidge memorabilia, the Museum displays the history of his life and times, and the beautiful new Foundation offices will be visible. Throughout the day, families will enjoy the activities at The Notch, including food and other refreshments, banners and buttons of the Coolidge presidency era, entertainment, and a

full day of fun for neighbors, supporters, visitors and guests. *You won't want to miss this important event.*

Culminating a whirlwind summer of activities, Thursday, October 7th will be another stellar event. The Calvin Coolidge Memorial Foundation will celebrate its 50th Anniversary at the John F. Kennedy Library in Boston. The program begins with a day-long symposium of speakers from 9 a.m. until 4:30 p.m. Space is limited. Speakers will discuss the relevancy of Calvin Coolidge today. Among notable authors and scholars will be Richard Norton Smith, Amity Shlaes, Gov. Michael Dukakis, and others. The symposium will be broadcast on C-SPAN. Attendees will be allowed to tour the JFK Library at the conclusion of the symposium. In conjunction with the symposium, a gala dinner celebration will follow at 6 p.m. beginning with cocktails in The Pavilion, and dinner in Smith Hall. Musical entertainment and the guest keynote

Students Discover — *If You Were There on August 3, 1923*

The unique story about how Calvin Coolidge was sworn in as the 30th President of the United States by his father is the topic of a new history and writing Outreach Program made available to local schools by the Calvin Coolidge Memorial Foundation. Students unravel the details of this series of events, think how this news was communicated and what it meant. They imagine the roles of people who happened to be involved that night and the stories told afterward. Students examine a replica of the "Lincoln Drape" lamp used in the swearing-in, a Coolidge family photo album, period newspapers, and a telegraph key. They view the presentation, "I Was Ready," told mostly with photographs, and take on a role of one of the 17 people directly involved that historic night.

Partners tell each other the story from their point of view and then write a short narrative telling of their experience as that person. Questions arise: "How does a switchboard work?" "Why is it called swearing in?" "What did President Harding die from?" "What kind of lamp was it?" "What

are the words of the Oath of Office?" The Education Coordinator from the Coolidge Foundation recently visited the Ray School in Hanover and shared this presentation with Alice Eberhardt's Fourth Grade. Here is a sampling of stories written by this enthusiastic class.

Our story begins. On August 2, 1923, Vice-President Coolidge went to the dentist in Woodstock, chopped rotting wood out of a maple tree in front of the homestead, helped a neighbor use a horse rake, and made plans to leave Plymouth Notch the next day to visit friends. That night President Warren Harding died in San Francisco.

Where were you and what did you experience on the night of August 2 to 3, 1923?

Aurora Pierce, Housekeeper to the Coolidges for 48 years

One day, when I woke up, John told me the news. I feel so honored to be the President's housekeeper! But knowing they did not ask me to come downstairs for the inauguration is embarrassing. I was sleeping, but I woke to the sound of talking. It

was coming from downstairs. I heard the words "ready . . . inauguration . . . president . . . states . . ." Thinking of nothing of those words at that moment because I was so tired, I drifted off to sleep again. The next morning I heard John shouting to me, "My son is the President, Aurora!" A lump formed in my throat. I suddenly remembered everything. How foolish of me so I blamed everything on the Coolidge family. A few days later, the newspaper came out. " . . . sworn in by his father by the light of a *dirty* kerosene lamp," it said. How insulting! Sweat and blood came out of cleaning everything! Those were the most interesting days of my life.

Grace Goodhue Coolidge, wife of Calvin Coolidge

I was woken up when my husband heard the news that he was to become the President. I was shocked, yet excited and didn't know what was going to happen next. At first, nothing was happening but then reporters of magazines and newspapers came to get a good article about the tragic event. My husband told me not to wake up our housekeeper because we didn't need any more people at the event slowing us down for making Calvin the official 30th President. There was a guard outside the white wooden house, making sure no one was going to come in. I was very overwhelmed. Finally at about 2:45 in the morning, my husband said the Oath with the Lincoln Drape lamp putting brightness on the eight people's faces around the dining room table. I was sad that President Harding had died but I was extremely happy that Calvin was the new president.

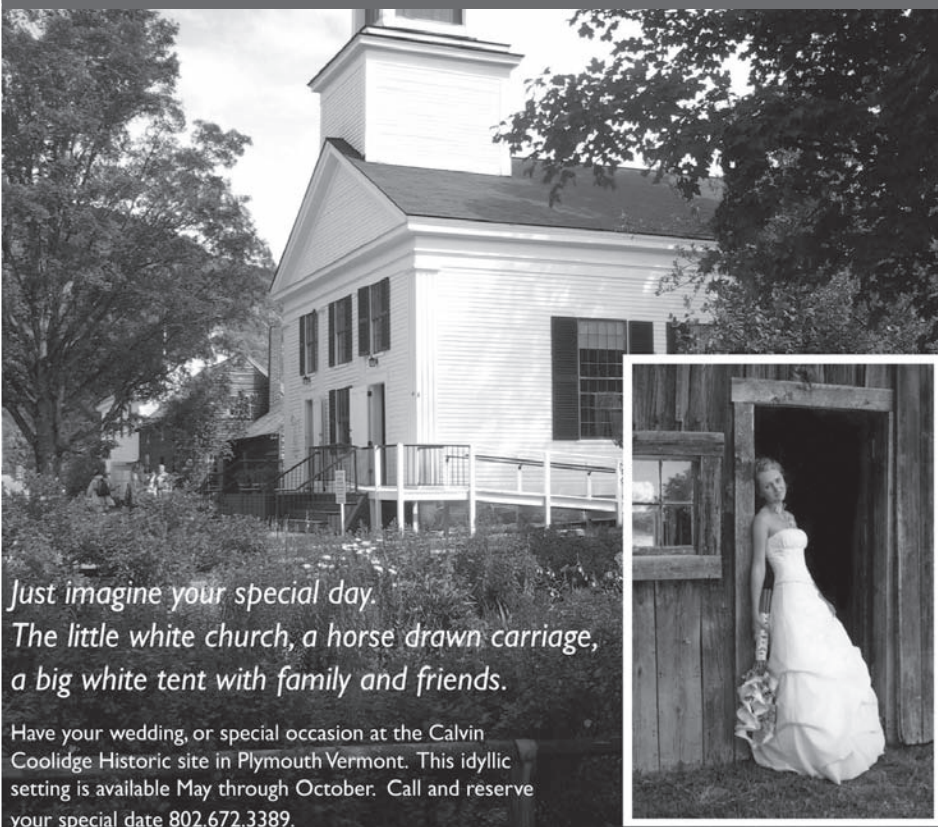
